The following are examples of repairs that would be covered under this endorsement, provided coverage is in order.

Examples:

- The customers air conditioning blower motor stops functioning. PVP would cover its replacement. Rental would also be available while its under repair. (Mechanical Breakdown Coverage)
- The customer loses or damages their key fob. It would be replaced without a deductible. (Key/Fob protection)
- The customers car sustains a minor dent that can be repaired without paint. This repair would be covered. (Minor Dent and Ding)

As far as the cost of the endorsement, we are still finalizing rate level and we expect to offer a wide range of rates. However, the majority of eligible customers will be offered a rate that is less than \$100 per 6-month term. We plan to file rates at the end of December.
