Pursuant to Section 59A-16-17(H) NMSA 1978 and Bulletin 2025-006, this serves as notification that MGT Insurance Company, intends to offer the following value-added service at no cost to its eligible insureds in the State of New Mexico for the purpose of reducing the probability of loss, the extent of loss, or both, from a covered property insurance event.

MGT Insurance Company offers the CM Wildfire Solutions program as a value-added service designed to help policyholders reduce the likelihood and severity of wildfire-related losses. The program provides wildfire risk assessments, on-site mitigation during threatening events, educational resources, and other wildfire preparedness services that have a direct nexus to loss mitigation by helping policyholders identify and address property exposures that could result in wildfire damage claims.

All eligible MGT Insurance policyholders in designated wildfire-exposed areas are automatically enrolled in the program at no additional cost. The service is provided at no charge to the policyholder, and the cost of the program is not included in or built into policy rates. Participation in and use of the services is not mandatory, and policyholders are not required to take any action or utilize any recommended mitigation measures in order to obtain, maintain, or renew coverage.

MGT Insurance Company communicates the availability of the CM Wildfire Solutions program through underwriting, loss control, policyholder, agent, and renewal communications, as applicable. The program is offered in a non-discriminatory manner based on objective wildfire exposure criteria and is intended to assist policyholders in identifying sources of risk, implementing loss mitigation measures, and reducing the potential severity of wildfire-related property losses.
